A. OFCC / SHP Discussion

The Board will not be asking for a bond issue in May, 2025. Charlie Jahnigen (SHP) provided a draft timeline of community engagement if the district moves forward with a levy on the November, 2025 election. Community groups and discussions are tentatively scheduled to begin in November. Also, SHP would engage smaller focus groups as well as larger community forums. A handout was provided.

B. District Data Review

Tim Cybulski (Assistant Superintendent) presented an overview of the district's achievement including the state report card. The district earned four stars on the state report card. The presentation also included discussion on the measures of achievement, progress, gap closing, graduation, early literacy and college/career/workforce readiness. Building principals will present to the board in the upcoming months to review building specific data.

Corey Kessler (Director) reviewed the Spanish Immersion program performance from data through the spring of 2024. The measures used were Speaking, Writing, Listening, and Reading. The students are significantly below targets in all 4 areas.

Candice Lessing (Director) reviewed universal screening and scoring levels as compared to benchmarks. Included in the discussion was Kindergarten data, as well as a behavioral analysis.
