#### TREASURER'S REPORT

- The Joint Committee on Property Tax Review and Reform
  - The Joint Committee on Property Tax Review and Reform released its final report on Thursday January 2nd after spending the past year studying Ohio's property tax system over eight hearings and receiving testimony from 60 witnesses, issuing 21 recommendations while acknowledging some proposals may contradict others.
  - The report is 835 pages long.
  - The 136th General Assembly will review the 21 recommendations which include evaluating reappraisal cycles, changing which types of levies impact the 20 mill floor, and having a means test which may provide property tax relief if citizens have tax bills that exceed a percentage of their income.
  - Oak Hills LSD local representative (Senator Bill Blessing) commented that he is supportive of reform that would hold school districts harmless, for which Oak Hills is grateful.
